

## WSQHA SHOW OF SHOWS FUTURITY RULES

- ☞ Both the exhibitor and owner must have a current NSBA memberships. The owners membership must match the ownership name on the registration papers. Membership cards must be presented at the time of entry. Memberships and show passes can be purchased at the show. Registration papers must be presented at the time of entry.
- ☞ Exhibitor must be a current WSQHA member to enter a horse in the futurity. Membership forms will be available at the show or online at [www.wsqha.com](http://www.wsqha.com)
- ☞ Entries; Only complete entries will be accepted. Be sure to have your entry form, registration papers, membership cards and a form of payment with you when you come to the office.
- ☞ Show passes allow you to ride in the futurity and win money BUT you will not accumulate NSBA points.
- ☞ Futurities that run separate from AQHA classes are open to all REGISTERED PAINT'S, APPALOOSA'S AND QUARTER HORSE'S
- ☞ Futurity entry must be paid in full at the time of entry, prior to the show deadline entry. NO OPEN CHECKS
- ☞ Payout checks will be held for 21 days pending clearing of all entry checks. If your check does not clear you will not receive your winnings until all financial responsibilities have been met. Checks will not be issued without a SSN on entry,
- ☞ NSF check fee is \$ 50.00. WSQHA reserves the right to pursue collection and prosecution to the fullest extent of the law.
- ☞ Non Pro exhibitors must possess a Youth or Amateur membership card in their respective registry.
- ☞ If paraphernalia is left in a stall assigned to you, you will be charged a fine of \$ 100.00
- ☞ All exhibitors, owners, trainers and staff related to futurity horse will abide by WSQHA rules. WSQHA shall be held harmless from injury, theft or damages occurred to any parties related to futurity horse.
- ☞ NO REFUNDS ONCE THE FUTURITY IS ENTERED. No Exceptions!
- ☞ Pre-entry will forfeit the post entry fee. HOWEVER, you can enter the futurity at the show with the post entry penalty of \$ 20.00
- ☞ COMPLETED ENTRIES only will be accepted. Be prepared to have copies of your registration and membership cards. Bring your check book. All NSBA memberships sold at the show are a separate check made out to NSBA. WSQHA reserves the right to refuse entry or demand cash payment for any reason. All paperwork must be in good order no later than 10AM, FRIDAY 5/23/08.
- ☞ One class per entry form. Please do not enter multiple classes on one entry form, regardless of the same exhibitor for each class.
- ☞ Stalls must be reserved in advance on a separate form

- ☞ All placings/points/winnings are subject to audit. Checks will not be dispersed until futurities are audited
- ☞ It is your responsibility to confirm we have your correct mailing address and SSN on file. Checks will be held until correct information is provided.
